69TH ANNUAL ICE FISHING CONTEST



On the day of the contest, a decision will be made whether to allow passenger vehicles and trucks to access the contest area. As of now, with the recent heavy snowfall, contestants should consider alternatives such as ATVs and snowmobiles. Updates will be issued on Facebook regarding conditions such as ice depth, snow cover, and slush. Off street parking will be provided for vehicles and trailers.

Each year for safety support, we welcome onsite the St. Louis County Sheriff's Volunteer Rescue Squad. In addition local DNR officials will be in attendance and together they are available to assist as needed. As always, at our events safety is a top priority.

Finally, please be aware that participants must abide by all the rules and regulations of the contest. All qualifying fish must be caught within the designated area of the UNS Ice Fishing Contest and be caught by the person registering the fish. Shelters are allowed. Each contestant may fish two lines. Everyone on the ice must have a participation ticket in their possession. All Minnesota fishing rules and regulations apply. Please be familiar with and obey the special walleye fishing regulations on Island Lake. All walleye caught that are 15 inches to 20 inches must be immediately released back into the water and cannot be included in the contest. Also the same holds true for any Northern Pike caught between 30 inches and 40 inches which must be immediately released.
