69TH ANNUAL UNITED NORTHERN SPORTSMEN ICE FISHING CONTEST

A Winning Day

The United Northern Sportsmen annual ice fishing contest was held on Sunday, February 19th at Island Lake across from the UNS grounds. There were 314 contestants on the ice competing for largest fish by weight. Numerous other prizes were also awarded. The event, originally scheduled for January 29th, had been postponed due to extremely cold weather.

The Gate Prize Drawing of \$1000 was won by Brett Hauer.

WINNERS IN THE ADULT FISH CATEGORY

First Place winner of \$1000 and Trophy went to Renee Budisalovich for catching a 1.47 pound Northern.

Second Place winner of \$500 and Trophy went to Ted Agarrison for catching a 1.06 pound Northern.

Third Place winner of \$250 and Trophy went to Layton Hedin for catching a. .97 pound Crappie.

Fourth Place winner of \$125 went to Misty Pawlowicz for catching a .95 pound Perch.

Fifth Place winner of \$75 went to Peter Kangas for catching a .83 pound Walleye.

WINNERS IN THE YOUTH FISH CATEGORY

First Place winner of \$50, Trophy, and Prize Package went to Wyatt McRae for catching a 1.02 pound Northern.

Second Place winner of a Prize Package went to Rain Benson for catching a .55 pound Walleye.

Third Place winner of a Prize Package went to Carsen Wolken for catching a .50 pound Perch.

A total of 21 fish were submitted at the weigh in station.

In addition, for those fishing the contest, there were many other prizes. During the three hour event we had 19 winners of our 10 minute drawings. Finally,16 raffle drawing winners were chosen at the end of the contest.
