FROM THE PRESIDENT

New board, new era for the club. As the newly elected President of the Club, my personal vision for this organization is to be a vehicle for the education of members and their families. Being a 501c(3) tax exempt organization we have an obligation to provide training concerning conservation, fishing, hunting and other outdoor activities. Most of the education will be directed toward the children and grandchildren of members. They are the future of the club. However, it is going to take an effort on the part of the members. We not only need volunteers for Instructors but to help with the maintenance of the facility. If a project needs a number of hands plan to get a call asking for assistance. Members can volunteer a few hours by being instructors, especially for State certified training: Snowmobile and ATV Safety, Watercraft Safety and Trapping Certification. The DNR will usually come to the retreat to train instructors if there are ten (10) or more participants. September of 2022, seventeen (17) persons were trained as Firearms Safety Instructors. UNS should develop a cadre of instructors in these disciplines.

My other goal for UNS is to give all members a voice in how the club is run. This can be accomplished by offering more opportunities for volunteers and by having more voting meetings to insure that the Board is following the wishes of its members.

I will be conducting Minnesota State POST Board Certified Range Safety Officer Instructor and Range Safety Officer training for any members that are interested. Peace officers will receive four (4) hours of CE credits and two (2) hours of CE credits, respectively. The first course will be February 24th, at the Retreat. The instructor course will start at 10:00am and the RSO course will begin at 12:00pm.

funds. About 2/3 of UNS moneys were invested in a high yield Fidelity fund rather than let it sit in a low yield account. Tina

Mike Hart spoke on what on his plans are for what he will bring to the club:

Firearm safety classes, more kids' activities.

Tina Sund would like to see more education for kids at the club.

Jim King (Spike) member since 2000 is interested in teaching kids useful skills.

Rob Murray wants to use his experience in sales to increase membership and get back lost members.

Cord Temo as a trainer he is interested teaching.

John Kohler not present to comment.

Tim Walburg is a certified range safety officer and taught archery.

Nancy Poppenberg is interested in increasing activities/volunteers at the club, also teaching children.

John Bathke financial/business background is interested in seeing support for treasurer in form of UNS finance committee, also teaching firearm safety.

Call for Nominations from the Floor: Chair: John Bathke called three times; No additional nominations.

Formation of Election Committee (3 members): Nominating Committee:

Was not necessary: there are more positions open than there are available positions.

Election of 2024 Officers/Board: Nomination Committee: A motion was made to cast a unanimous ballot (M/S/C). Election was held in accordance with UNS rules.

Installation of Newly Elected Officers: Will be done at the January meeting.

Membership Approval of Board of Directors Recommended UNS 2024 Budget: John Bathke commented on budgeting process. UNS did not have a budget in the past, a budget is a fluid document that can change depending on club needs; for example, unexpected expenses not budgeted for. Tina Sund made note of the following possible expenses: Fencing, Lawn Mower replacement, Camp Host Building Repair and Legal Fees.

John explained that we are approving just the regular budget not the Additional expenses as noted on the 2024 budget. Tina Sund commented, expenses include acquiring a new riding mower, old one is in rough shape and could be risky to operate. She explained the 2024 budget details, especially increase in expenses due to current economic conditions. Tina Sund: Tina reviewed the budget for 2024. A motion was made to approve 2023 Budget (M/S/C).

August 17, 2023 Rules Changes: Rule Changes, Tina Sund reviewed the Rule Changes, a discussion followed in particular the number of guests allowed per member (10). A motion was made to allow 6 guest per member, dropped due to lack of 2nd. A motion was made to a change in **Guest Information**: "10 guests" will be changed to: "number of guests allowed is 4 adult guests per membership, not including children (under age of 18)" (M/S/C). One opposed. A motion was made to remove: "Subsequential day passes can be purchased for up to 3 nights" from **Campground Information (M/S/C)**. No opposed votes. A motion was made to change: Membership Guests Passes are not available for overnight guests over the age of 18." (M/S/C). No opposed votes.

Sue Bathke thinks we should have a Membership Survey; discussion followed on what to include and when to survey. The previous informal survey was brought up. This will be discussed at a future meeting.

UNS FIREARMS SAFETY CERTIFICATION COURSE

UNS will be sponsoring its first Firearms Safety Certification Course in years. This is a five (5) day course NOT the online course. Field days for the online students will be scheduled in the near future. There are twenty (20) slots for students. Held March 26-29 from 6pm to 9pm and on March 30th from 10am to 3pm at the clubhouse. The course is open to members first. This is on a first come first served basis. If a student registers for this course they MUST attend all five days, no exceptions. Member instructors that received training in September 2022, are encouraged to attend, especially on March 30th. To maintain an instructor certification, you must conduct a course at least every two years.
